**ORDER**

The District Collector and Chairman DTPC Kannur submitted project proposal 'MANGALASSERY BOAT RACE PAVILION'. The estimated cost of the project is Rs.68,40,000/- (Rupees Sixty Eight Lakhs Forty Thousand only). Considering the importance of the project in the tourism perspective, the Director, Department of Tourism requested Government to accord administrative sanction for the implementation of the project at an estimated cost of Rs.68,40,000/- (Rupees Sixty Eight Lakhs Forty Thousand only). 2) The working Group Meeting held on 20.08.2016 considered the proposal of the Director, Department of Tourism and approved the project for an amount of Rs. 68,40,000/- (Rupees Sixty Eight Lakhs Forty Thousand only)

3) Government considered the proposal in detail and are pleased to accord Administrative Sanction for the project 'MANGALASSERY BOAT RACE PAVILION' at an estimated cost of Rs 68,40,000/- (Rupees Sixty Eight Lakhs Forty Thousand only) subject to the condition that availability of land should be ensured along with the statutory requirement before releasing funds to the project.

5) The expenditure for the purpose will be met from the head of account "3452-80-800-79-District Tourism Promotion Councils and DMC (Plan)" in the current years budget(2016-17). Releasing the amount to the above project will be limited to the expenditure and the Budget Provision for current financial year. All the relevant procedural and codal formalities and the conditions stipulated in G.O (P) No.408/07/Fin dated 07.09.2007, G.O.(P)No311/14/Fin dated 30.07.2014 and G.O (P) No.11/15/Fin dated 08.01.2015 should be followed strictly.

6) The work will be executed through the DTPC, Kannur and will be completed within a period of 12 months.


