ORDER

1. Being located in the state capital Thiruvananthapuram, the Guest House, at Thycaud in Thiruvananthapuram is one of the important Guest Houses of the Department of Tourism. State Guests, Guest of Government, other VVIPs and Government officials occupy the Guest House for their stay frequently. This is also an important place for conducting meetings of Government Departments and other organisations. Prompt renovation, maintenance and proper upkeep of the Guest House is highly essential. Accordingly, the Department of Tourism, through the Public Works Department prepared estimates for the repair and maintenance works at Government Guest House, Thycaud, Thiruvananthapuram at an estimated cost of Rs.1,65,00,000/- (Rupees One Crore Sixty five lakhs only) . This includes maintenance of civil works, maintenance of Electrical, plumbing, AC repair, fire equipments, up keeping of premises and repair, replacement of service connections etc.

The Director, Tourism as per the note read as 1<sup>st</sup> paper recommended to issue administrative sanction for the above work at an estimate for Rs.1,65,00,000/- (Rupees One Crore Sixty five lakhs only).

4. The Departmental working group meeting held on 20/08/2016 considered the proposal and approved the same.

5. In having considered the proposal in detail the Government are pleased to accord Administrative Sanction for the repair and maintenance works of Govt. Guest House, Thiruvananthapuram at an estimated cost of Rs.1,65,00,000/- (Rupees One Crore Sixty five lakhs only).

6. The expenditure in this regard will be met from the h/a "5452-01-800-87 upgradation, creation of infrastructure and Amenities Guest House (Plan)" limiting the expenditure to the current year's budget provision.



The work will be executed through PWD, Thiruvananthapuram Division subject to the condition that the procedural and codal formalities and the conditions stipulated in GO(P) No.408/07/Fin dated 7-9-2007 and G.O.(P) No. 311/14/Fin dated 30.07.2014 should be followed strictly. The work will be completed within a period of 6 months.
